The American Red Cross Resuscitation Suite and the American Heart Association (AHA) HeartCode program are self-directed e-Learning programs that offer Basic Life Support (BLS), Advanced Life Support (ALS), and Pediatric Advanced Life Support (PALS) in an online format. These programs provide cognitive and hands-on training, using automated feedback manikins.

All applicable textbooks, science overview videos, and reference materials are electronically embedded and are accessible throughout the courses. Materials remain accessible to participants for two years after the date of completion of the online courses from the participant's transcript.

- I. The cognitive portions of the eLearning course can be completed online through [Organization]. After successful completion of the cognitive portions of the programs, participants will receive a completion certificate before proceeding with the self-guided skills session.
 - a) Hands-on skills testing will be accomplished through the following methods:
 - Testing with the designated automated feedback manikin OR
 - Testing with a certified American Red Cross or AHA Instructor

b) The option to involve a certified American Red Cross or AHA instructor to perform skills check for a participant is approved for the following purposes:

- Physical exemption with a physician's excuse
- Outlying physician offices and clinics without the designated automated feedback manikin. Note: If your site is affiliated with or located near a facility with automated feedback manikins, that facility may be utilized as your testing location.
- Remediation purposes.
- II. **Recommended Remediation Process:** If a participant has attempted the automated feedback manikin in more than one 30 -minute skills session, the instructor or site administrator should assist the participant by facilitating skills on the manikin. If the participant is still unable to complete after the facilitated session, then a certified instructor should remediate the skills. If the instructor is confident in the participant's ability, the instructor may mark the participant as passed using HealthStream's Skills Validation Tool.
- III. For participants who have completed either BLS courses, AED testing during the skills testing session is not required because AED use, and pad placement and safety are reviewed in the online cognitive courses. However, participants may use the AED trainer in the skills practice session.
- IV. To receive an online resuscitation credential, the participant must complete all skills on the skills testing checklist (with either the manikin or instructor) for each of the eLearning modules completed.
